

## Why Does Bradford Need a Clean Air Plan?

- Mandated by government in 2018 to implement CAZ
- Persistent and widespread exceedances of the legal limits for nitrogen dioxide throughout the City



## NO2 levels in 2018




## **ENVIRONMENT ACT 1995**

- Environment Act 1995 (City of Bradford Metropolitan District Council) Air Quality Direction 2020
- Schedule 1, Article 3
- Class C Charging Clean Air Zone
- To be implemented as soon as possible and at least in time to bring forward compliance to 2022




# **Objectives of the Clean Air Zone and how it works**

- 30-35% reduction in no2 in some of the most deprived areas in the district
- Improvements everywhere, biggest improvements at schools
- £31.5m of funding to renew vehicles
- CAZ revenue ring-fenced to further improve air quality



### **Overview of Bradford Charging Clean Air Zone Service Operations**





## People, processes and technology to set up and run the CAZ – our roadmap to launch and progress to date

- Procurement of 400 ANPR cameras / ANPR system and extension of fibre network, requiring 16km of new network duct
- Recruitment of new CAP Operations team including Grants and CAZ officers
- In-house development of multiple new IT systems
- Publicity campaign launched June 2021
- Clean Air Support programme for local SME's has started

# What's worked well, what hasn't and lessons so far

- Use of in-house resource has saved cost
- Time-scales for implementation are longer than originally envisaged
- Actively engage internal stakeholders early (e.g. Procurement IT and HR)
- Plan for Behaviour Change, not just implementation
- Consult with other authorities all are willing to share experience





#### Bradford Clean Air Plan Engagement: Seldom Heard Communities






